# **Instructions to mail bidders**

(update of August 28th 2019)

ENGLISH

Since August 2019, the Online Auctions of iNumis available only on Biddr.ch.

### **1. Principle**

In Live Auctions, lots are attributed to the highest bidder. Bids must be submitted by registering on the website <u>https://www.biddr.ch</u>, by post or email.

#### 2. Lots exhibitions

If you can, we suggest you to take the opportunity to personally view the lots at our premises during opening time, by appointment only. Otherwise they are available on line on the website <u>https://www.biddr.ch</u>. Once the catalogue is on line, the lots are available for around one month is on line until the end date of the sale. #### **3. Deontology**

Since we offer the possibility to directly view the lots (see point 2), we will not accept any claim about the description of the items, once the sale is closed. The pictures and descriptions of all the items are proposed in good faith and are based on the current numismatic theory. We reserve the right to reject any consignment and any bid without any explanation. iNumis guarantees the utmost confidentiality in handling the personal data of its clients : do not hesitate to communicate any change in your personal data by sending us a written demand.

#### 4. Authenticity

All the lots are guaranteed authentic. The photos in the online catalogue represent the actual items being sold. Any claim about the lots must be communicated in writing within 15 days after the delivery of the lots; however, no return can be accepted without a prior written agreement. Bulk lots can not be returned for any reason.

#### **5.** Dates

Bids must be submitted by registering to <u>https://www.biddr.ch</u>. Do not wait until the last moment to create your account !

### 6. Results

Realized prices will be posted on the website <u>https://www.biddr.ch</u>. The realized prices will also be posted to all the bidders. Invoices are due and payable immediately upon receipt. The statutory rate per month shall be payable on invoices not settled within 20 days of the closing date.

#### 7. Shipping

Upon reception of the payment, lots can be picked up for free at our premises or shipped. Shipping and handling fees are  $10 \notin$  for European Union and  $20 \notin$  for the rest of the world ( $<500 \notin$ );  $15 \notin /30 \notin$  (from 500 to 1499  $\notin$ ); or  $20 \notin /40 \notin$  (> 1500  $\notin$ ).

#### 8. Prices

The first price is the minimum you can bid; all bids below the starting price will not be accepted. The second price is an estimated price according to the current numismatic market. Lots may be sold above or below the estimated price, according to their quality and rarity.

## 9. Successful bidders

The highest bidder will be the final buyer. When identical bids are received for the same lot, the lot will be awarded to the earliest bidder. Increment details on the website <u>https://www.biddr.ch</u>.

## 10. Buyer's fees

10 % of buyer's fees (VAT not included, hence 12 % ATI) will be added to the bill. They will appear on the PRO FORMA invoice that you will receive.

## **11. Unsold lots**
